

# Grassfield High School

In order to park on Grassfield High School (GFHS) property, students must adhere to all rules and regulations as set forth by GFHS. Driving and parking a vehicle on school property is a privilege at GFHS, one that may be revoked without refund for violating parking regulations or any behaviors or actions that create an unsafe environment as determined by school officials. Students are encouraged to use Chesapeake Public Schools bus transportation. It is the student's responsibility to arrive on time. An Excused Tardy WILL NOT be given for being late.

## OBTAINING A PARKING PERMIT

In order to apply for a parking permit, students should visit [www.gfhgrizzlies.com](http://www.gfhgrizzlies.com) to submit an online application. Upon completion of the application, students should verify all submitted information as well as print and sign a copy of the online *Confirmation Form*. **The signed Confirmation Form and a valid driver's license** should be brought to the Grassfield High School on one of the following dates:

\*\* NOTE: Those students who do not have internet access may pick up a copy of the parking permit application from the main office. \*\*

Parking permits will be sold for \$25.00 (CASH ONLY) and will **ONLY** be sold to seniors and juniors. **Sophomores are NOT eligible to obtain a parking permit.** If a student needs to register a second vehicle, there is an additional \$25.00 cash fee. Students who are not able to obtain a parking permit prior to opening day should not drive to school. Students must have a parking permit PRIOR to parking on school property. Parking permits will be sold until the predetermined supply is exhausted.

## PARKING REGULATIONS / STUDENT USE OF MOTOR VEHICLES

1. Bus transportation is provided for all students of Chesapeake Public Schools. *Driving any motorized vehicle to school is a privilege.*
2. Students will secure a parking permit PRIOR to driving or parking a vehicle on school property.
3. **STUDENTS WILL BE ASSIGNED A SPECIFIC PARKING LOT (Senior – Blue Lot, Junior – White Lot) FOR THE 2020-2020 SCHOOL YEAR.** Students are prohibited from parking in any parking lot other than their assigned parking lot, unless approval from an administrator or security has been obtained. Spaces in each lot will be available first come, first served, depending on when the student arrives to school.
4. Students will operate motor vehicles in a safe, careful manner at all times and in accordance with the laws of the City of Chesapeake and the Commonwealth of Virginia.
5. ALL vehicles parked on school property must be registered with the school and must display the school issued parking permit on the inside of the lower left corner of the back window of the vehicle, and must be parked in their designated parking lot.

6. Students will not falsely represent, counterfeit, or photocopy parking permits. Students should remove any old or expired GFH parking sticker from their vehicle.
7. Students will notify the security staff of any vehicle or license plate changes that occur during the school year.
8. Students will exit vehicles, lock their vehicles, leave the parking lot, and enter the school building quickly upon arrival to school.
9. Students will not return / go to any vehicle or the parking lot without administrative permission. Students will leave school promptly at their scheduled departure time.
10. Students will obey all signs and pavement markings, as well as directions from school staff.
11. Students will not engage in such activities as:
 

A. Reckless driving	E. "Racing engines"
B. Speeding	F. Driving over curbs
C. Spinning wheels	G. Playing excessively loud music
D. Blowing horns	H. Cutting in front of line
12. Students will yield the right of way to all buses each afternoon.
13. Students will promptly report to the Main Office all accidents on school property that involves personal or property damage.
14. Student handicapped parking is available only with a valid DMV issued handicapped permit.
15. Private vehicles are prohibited from the bus lane. The bus lane is to be used by buses only!
16. Students are not allowed to use the visitor or staff parking spaces for any reason.
17. Vehicles parked on school property are subject to random searches by the canine units of the Chesapeake Police Department and/or the Virginia State Police.
18. Grassfield High School assumes no responsibility for the care or protection of any vehicle or its contents at any time.
19. Transfer of parking permits from one student to another for any reason is strictly forbidden. Students are not to sell, give, receive or by any other device transfer parking permits. Violation of this policy will result in the suspension of all parties involved as well as the revocation of parking privileges at Grassfield High School for up to ONE CALENDAR YEAR.

**POSSIBLE CONSEQUENCES RESULTING FROM A VIOLATION OF ANY OF THESE REGULATIONS AND EXPECTATIONS PERTAINING TO PARKING AND THE USE OF A MOTOR VEHICLE ON SCHOOL PROPERTY INCLUDE, BUT ARE NOT LIMITED TO:**

Parental contact; **Assessment of monetary fines (\$25 – School Board Policy 4-8 Fees)**; Suspension or revocation of parking privileges; Suspension of student (OSS), Towing of vehicle at the owner's expense; Notification of police

**Leaving school during the school day prior to approved departure time or transporting another student off of school grounds prior to their approved departure time will result in:**

- **1<sup>st</sup> Offense - Suspension of the student(s) and suspension of driving privileges for up to twenty school days.**
- **2<sup>nd</sup> Offense – Suspension of the student(s) and revocation of driving privileges for the remainder of the school year. The parking decal will be immediately issued to another student on the waiting list.**

**PARKING PRIVELEGES MAY ALSO BE SUSPENDED OR REVOKED FOR EXCESSIVE TARDIES TO SCHOOL, ABSENCES, OR OTHER DISCIPLINARY CONCERNS**
