



Hickory Middle School 2019-2020 Study Hall Permission Letter

This year with the importance of academics in our schools, we are pleased to offer after-school study hall sessions to all students here at HMS. The program will be on-going throughout most of the school year. Our goal is to ensure the opportunity for the success of all our students.

Study Hall will be offered each **Tuesday and Wednesday** from 3:40-4:25 unless indicated on our school calendar. The study time will allow students time to complete homework and other class assignments, study for tests and quizzes, and complete reading assignments in a quiet environment. There will be tutors available to provide assistance in core subject areas as needed. Again, all students in the school may participate. Student athletes who are in a probationary nine weeks period will be required to attend study hall. All others may attend at your discretion. Students should only plan to stay back if they have work to be completed.

This form serves as the permission slip for Study Hall for the entire 2019-2020 school year even if your child does not attend until later in the school year. The program will begin **Tuesday, September 17, 2019**.

Students should report directly to the cafeteria after dismissal at 3:28 p.m., sign in and sit quietly. They will be allowed to have light snacks they bring and/or use the restroom prior to 3:40 p.m. when the tutors arrive.

Bus transportation will be provided. We will be releasing students from the 100 hallway. If you elect to transport your child, please make sure you arrive no later than 4:25 p.m. Please leave the cul-de-sac and curbing near the gym open for our busses. Also of great importance, we cannot have your child wait without supervision if you are late. He/she will be placed on the appropriate bus for your neighborhood if there is no other transportation on-site when the busses are released at approximately 4:30 p.m. Please have attendance and transportation arrangements understood by you and your child prior to his/her staying back. Using the school telephone is not allowed except for emergencies.
